UC Presidential Campus Safety Guidelines (June 2021)

#	Guideline Element	Description
1	Community and Service Driven-Safety	Campus safety policies and practices must reflect the needs and values of our diverse community and be in service to them. This fundamental idea is reflected throughout the plan.
2	Holistic, Inclusive and Tiered Response to Services	Campuses will integrate policing with mental health, wellness, basic needs, and bias/hate response through inter-departmental partnerships and cross-trainings. Multi-disciplinary teams will triage behavioral health crises, conduct wellness checks, and safely connect individuals to coordinated care, including health and social support resources.
3	Transparency and Continuous Improvement Through Data	Campuses will collect and publicly share uniform campus safety data on a UC- wide dashboard to empower the UC community and inform change.
4	Accountability and Independent Oversight	Police accountability boards on every campus will provide a robust complaint and investigation process to ensure that officers are acting consistently with rules, policies and the law.

1	Adopt a Mission Statement and Set of Core Values Underlying Public Safety	Develop and adopt a mission and set of core values underlying public safety as desired and envisioned by the UCI community.
2	Develop a Holistic Campus Safety Framework	Align performance standards with campus safety standards and values as determined by the UCI community.
3	Data Collection and Management to Enhance Assessment and Evaluation of Efficiency	Improve data collection and management to enhance the assessment and evaluation of the efficacy and practices of the Department, and to determine what type of public safety services are needed.
4	Construct a More Responsive Compliant Investigative Process and Feedback Mechanism	Construct a more responsive complaint investigative process and feedback mechanism that promotes campus safety expectations and community standards.
